#### **New C-PORT Chairman Appointed by Board of Directors**

C-PORT (Conference of Professional Operators for Response Towing) held its 30<sup>th</sup> Membership Meeting on November 14, 2016 at Wyndham Lake Buena Vista, Orlando, FL. Along with committee reports and industry issue discussions, the membership elected its 2017 C-PORT Board of Directors and the 2017 C-PORT Executive Board was named.

LeBlanc has served on numerous C-PORT committees over the years including serving as chairman of the standards and education committee.
